Is Currently Accepting Applications for Head Start Children (3 and 4 years old) this upcoming program year 2024-2025.

Head Start Parents please provide the following information:

1. The child's age documentation (such as a birth certificate, etc.)



- 2. The child's immunization (up-to date shot) record on a 121 or 122 form
- 3. The family's proof of income for the previous 12 months

(Examples: Proof of SNAP benefits, TANF documentation, SSI documentation, Self-Declaration of Income with verifying sources, 2023-1040 tax form, 2023- letter from Social Security Administration (SSA), letters from employers, Self-Employed Declaration or Foster care payments.

- 4. The child's Medicaid or insurance information
- 5. Proof of residency, (if applicable).
- 6. A statement or healthcare plan from a doctor if your child has a food allergy or a chronic medical condition such as asthma or diabetes, (if applicable).
- 7. A current Individualized Education Plan IEP/ IFSP if the child has a diagnosed disability, (if applicable).

Please Have Documents When Applying

Applications must be completed within 30 days of applying

Comprehensive Head Start services are provided at no cost to families that qualify.

Children and families who are experiencing homelessness, in foster care, disabled and/or teen parent will be given first priority. All others will be considered.
